Squares are hung in the following particular order: Blue (sky), White (air), Red (fire), Green (water) then Yellow (earth).

Jope also shared correspondence from Dr. David Swann who thanked us for the opportunity to speak at the Entheos retreat. David gave his honorarium to ATZIN.org. Brian Pearson also sent a note of gratitude.

Rev. John Crowdis has advised that the board recommends Lakeview United Church as the best place for St. Matthews congregation to come once the doors close.

This creates an anticipated \$25,000 deficit budget for 2020.

Janet Layton has prepared a request for a grant from Canada Summer Jobs. Certain requirements must be met in order to qualify for the grant including designating a supervisor and mentor for the position that will be advertised. Jope is willing to act a supervisor to the temporary position. Wayne Gordanier will act as mentor. Janet explained that this grant does not require that a student is hired, but there must be a focus on training and the grant is designed to offer jobs to groups exhibiting barriers to employment. Janet anticipated that the cost to LUC for a 10 week summer position will be approximately \$2200 if a grant is received. Council agrees that Janet should submit the application. A decision as to whether or not to advertise and hire a summer employee will be further discussed. If a grant is not secured will a summer position still be offered?

Joel Den Haan and Roger Scroggin joined us to introduce and explain a space use request from Imam Syed Soharwardy who represents the Islamic Supreme Council of Canada here in Calgary. This group of Sufi Muslims, the Al Madinah Islamic Calgary Assembly are looking to offer prayers services in SW Calgary. A lengthy discussion included how this opportunity is in alignment with the intentions set out when we chose to erect a peace pole and confirms our status as an inclusive community. We recognize this to be more than a simple rental and that a more meaningful relationship with the Al Madinah Islamic community is expected to develop. It will be important to share this information with members of our congregation as it may be confusing to some. It was decided that a 3 month trial period will be the best approach and that we should ask Imam Syed Soharwardy to help introduce the relationship by attending a Sunday service in the near future.

**Motion:** Council recommends that a letter of intent be published on the LUC website indicating we will explore the opportunity to develop a relationship with the Al Medinah Islamic Calgary Assembly beginning with a 3 month trial period in the Spring of 2020. Moved by Daryl Sedor. Seconded by Beckie Scroggins. CARRIED

**ACTION ITEM:** Jope to prepare letter for the website and to invite Imam, Syed Soharwardy to speak at a Sunday Worship service.
