Paige Martin continues to submit reports for this committee.

Heather Mayers will coordinate Pledgefest again this year. She plans to get started prior to the end of September.

ACTION ITEM: Jope will prepare a letter for Pledgefest.

With dwindling numbers of volunteer counters a meeting will be held to establish new procedures.

The PossAbilities group is no longer renting space. They left with \$6305.50 in unpaid rent. There is some debate of whether to pursue payment of the rent considering they are a not-for-profit group and may never be able to pay. Should this income be written off? Should a collection agency be hired?

ACTION ITEM: It was decided that Carolyn Bosch will

make enquiries to the Alberta Government to assess whether any action should be taken.

Many thanks to Roger Scroggins for the time and effort taken to assessing and preparing a rental offer to Calgary Girls Choir.

**Motion:** Lorna Flack moved that LUC Council endorse the space rental proposal for Calgary Girls Choir as prepared by Roger Scroggins. Seconded by Lesley Sedor. CARRIED.

Regarding our new renters, Student Inc., so far, all is well. Jope will meet with the Principal at Jennie Elliott soon to discuss safe use of the church parking lot by parents. He will also establish times when the parking lot is "off limits" to Jennie Elliott parents such as November 11.

## Reaching Out, Lesley Sedor

Thank you letters for donations made to various organizations have been received. Lesley will share these with the congregation by placing them on a notice board in the narthex. It was suggested that during Pledgefest Lesley convey some data to the congregation about who receives support from Reaching Out and in both dollars and time.

## Faith Formation & Worship, NO CHAIR, no report

There is an upcoming meeting where Jope hopes to encourage someone to act as Chair to this committee.

#### Fellowship & Caring, Lorna Flack

This small committee continued to host many fellowship events over the summer with a potluck in August and Sandwich Sunday in September. Upcoming events include Souper Sunday on November 10. Lorna requested that Jope contact Marshall Pope to invite the Boy Scouts to attend the Remembrance Day Service and lunch.

Lorna has requested that if there are NO volunteers for coffee on a Sunday that we do not serve coffee on that day. There was some debate as to whether this would be an effective strategy to get others (people who don't already help) to volunteer. It is felt that people need to know that it is not necessary to provide food and that someone will assist with coffee preparation if one is unsure of what to do.

more participation AND thank Lorna for all her help.

**Motion:** Daryl Sedor moved that an announcement be made at the church service stating that if No volunteers sign up, No coffee will be served. Food is optional. Seconded by Paige Martin. CARRIED.

**ACTION ITEM:** Daryl Sedor will chat with the

men who regularly attend coffee after service to see if he can coordinate their participation. Beckie Scroggins will make the announcement prior to Sunday worship.
